 - A motion to approve the recommended **Transportation** budget of **\$1,800,055.00**, was made by Mrs. Ducey and seconded by Mr. Calnan. On a vote of 6-0, the motion passed.
- 3. Approval of School Improvement Plans:
 - <u>Hubert Kindergarten</u> Principal Dr. Mary McCarthy presented her School Improvement Plan for Hubert Kindergarten. A motion to approve the Hubert Kindergarten *School Improvement Plan* was made by Mrs. Ducey and seconded by Mrs. Nelson. On a vote of 6-0, the motion passed.
 - <u>Forest Avenue</u> Principal David Champigny presented his School Improvement Plan for Forest Avenue. A motion to approve the Forest Avenue Elementary *School Improvement Plan* was made by Mr. Calnan and seconded by Mrs. O'Brien. On a vote of 6-0, the motion passed.
 - JFK Middle School Principal Brian Daniels presented his School Improvement Plan for JFK Middle School. A motion to approve the JFK *School Improvement Plan* was made by Mrs. Ducey and seconded by Mrs. Nelson. On a vote of 6-0, the motion passed.

A motion to approve the Assabet Valley Collaborative Agreement amended to include Grafton as a new member was made by Mrs. Ducey and seconded by Mr. Calnan. On a vote of 6-0, the motion passed.
- <u>Approve of Wilson Fundations Language Program Contract</u>: Dr. Lyons recommended approval of the contract for Wilson Fundations Program for purchase of Fundations materials for students. A motion to approve contract, as presented, with Wilson Fundations Training Corporation in the amount of \$28,833.95, was made by Mr. Calnan and seconded by Mrs. Ducey. On a vote of 6-0, the motion passed.
- 8. <u>Approval of TenMarks Contract:</u> Dr. Lyons recommended approval of a contract with TenMarks for licensing of a web-based mathematics instructional program. A motion to approve contract, as presented, to TenMarks in the amount of \$8,000.00, was made by Mrs. Ducey and seconded by Mrs. Nelson. On a vote of 6-0, the motion passed.

IX. Superintendent's Report – Dr. Lyons reported on the following:

The response of students, staff and community in regard to the tragic death of a High School student. Dr. Lyons expressed his pride in being part of a staff and community that responded with such care by putting in place counseling and support structures so quickly.

High School Graduation and all Senior Week activities were exceptional and there was much positive feedback from staff and parents. He thanked the senior class advisors Beth Ferns and Steve Martin and acknowledged the planning and execution of advisors, students and staff. The Guidance Department provided great leadership in event planning and recognitions and scholarships.

The Cyber-Bullying and Social Media Workshop was held on May 17th by the Middlesex District Attorney's Office.

The TellMass survey link is now available and results will be reported at a future School Committee meeting.

Comcast has gone digital and School Committee and Selectmen meetings will now be on Comcast Channel 99.
